### **AI INTEGRATION**

**1**

- Launch a comprehensive AI training program for AHIMA members in collaboration with the council.

### **BRIDGING HIM AND NURSING IN CDI**

- Measure the impact of these educational initiatives by tracking changes in denial rates or appeal success rates among AHIMA members who have participated in the training.
