Dear Leader McConnell, Leader Schumer, Chairman Alexander, and Ranking Member Murray:

The undersigned organizations represent the nation's clinicians, hospitals, health systems and foremost experts in health informatics and health information management. We write today to express our strong support for Section 1 of [H.R. 7898](#), which passed the House by voice vote on December 9, 2020. This language can also be found in Section 502 of S. 1895, the Lower Health Care Costs Act, which was reported out of the Health, Education, Labor and Pensions (HELP) Committee on July 8, 2019.

Healthcare organizations are constantly under attack from bad actors seeking to disrupt their operations or unlawfully release patient data. H.R. 7898 gives much-needed protection to healthcare providers who follow recognized security practices to fend off these attacks. Specifically, this legislation would require the U.S. Department of Health and Human Services (HHS) Office for Civil Rights (OCR) to consider a covered entity's use of recognized best practices, such as those established under Section 405(d) of the Cybersecurity Act of 2015, when assessing fines and audits related to the Health Insurance Portability and Accountability Act (HIPAA). This will incentivize the adoption of cybersecurity practices by acknowledging that providers who have been acting in

good faith should not be penalized by OCR and promote increased communication between providers and HHS during the crucial early stages of an attack.

We applaud the bill's sponsors, Rep. Michael Burgess (R-TX) and Rep. Peter Welch (D-VT), as well as Chairman Frank Pallone (D-NJ) and Republican Leader Greg Walden (R-OR), for their leadership on this issue and urge the Senate to swiftly pass this important legislation.
